

National Youth Festival (NYF) is organized every year from 12th to 16th January, 12th January being the birth anniversary of Swami Vivekananda, the great philosopher and thinker, is observed as National Youth Day. The Festival is a National Integration Camp on a national scale. It used to be organized in physical mode in a State willing and equipped to host the same. However, due to Covid situation, this year, this Ministry of Youth Affairs and Sports is planning to organize the 24th National Youth Festival, 2021 from 20th December, 2020 to 16th January, 2021 in virtual/ hybrid mode with the support and participation of all States/UTs.

2. For effective participation, all State Govts may conduct mini festivals at State level by organising various Competitive/ Non-competitive events. The festival may be organised at State/UT level in 2 phases as under:

- Phase I (State Level): 20th Dec to 31st Dec, 2020: All States/UTs may conduct competitions by involving youth of the respective State/UTs on any 3-4 days between 20th Dec to 31st Dec, 2020. The finalists selected may then participate in Phase II.
- Phase II (National Level): 12th - 16th Jan, 2021: All States/UTs may conduct Online and Offline Programmes and D/o Youth Affairs, M/o Youth Affairs & Sports will conduct a series of Online/Virtual Programmes at National Level. A contingent of around 75 to 100 youth including cultural troupes may be selected to participate in the National Youth Festival to be organised at State/UTs Capital.

3. State Level Committees may be constituted to undertake the conceptualisation and implementation of the activities related to the Festival with the following suggestive composition:

- Principal Secretary, YAS of the State/UT Govt.
- Any member (s) nominated by Principal Secretary, YAS of the State/UT Govt.
- Regional Director, NSS
- State Director, NYKS
- State Representative of the Selected Event Management Agency
- Representative of NIC of the State

4. The role of the State Level Committees may be the overall arrangement of the food and lodging of the participants, ensuring presence of the youth in various Competitive and Non-competitive events, ensuring availability of the infrastructure for conduct of the festival in the State, publicity of the festival for maximum participation of youth through various mode, ensuring adherence of guidelines of M/o Health & Family Welfare to avoid the spread of Covid-19, live online streaming of the festival, etc.

5. While finalizing the composition of the contingent, it may be seen that young persons having proficiency in performing arts are included, in view of a large number of events being organized in the Festival. Further, the ex-National Youth Awardees may be considered for inclusion in the State contingent, if deemed suitable. A copy of list of the National Youth Awardees for last three years is attached as Annexure-I. The young persons who have participated during the last three Festivals, may not be included in the Contingent. The State Government may involve the Nehru Yuva Kendra (NYK) officials while selecting the participants.

6. The competitive and non-competitive events that are usually organised during National Youth Festivals and the infrastructural requirements on the part of the State for conduct of the same are attached as Annexure-II.

7. This Ministry is in the process of hiring an agency which will provide technical and other support to the State Govt. for organising the festival. The details of the same will be shared with the State/ UT Govt.s shortly.


8. As regards, financial assistance from Central Govt., central share of Rs. 15 Lakhs per State/ UT may be sanctioned on receipt of the proposals. The expenditure over and above this amount may have to be borne by the concerned State/ UT Govt.

9. With a view to have a detailed discussion regarding the concept of Organisation of 24th National Youth Festival in virtual/ hybrid mode, a meeting will be taken by Secretary, D/o Youth Affairs, M/o Youth Affairs & Sports with Principal Secretaries of all States/UTs on 14th December 2020 at 12:00 PM through video conferencing. The link of the meeting is being shared via E-mail.

10. I am confident that your State/UT contingent would put up a grand display as has been done in the past. I would request you to kindly confirm your participation in the National Youth Festival through virtual / hybrid mode and also confirm the availability of requisite infrastructure to conduct the same, latest by 17th December, 2020 to this Department

Events conducted during the National Youth Festivals and Infrastructural Requirements on the part of State/ UT Govts

Competitive Events: Competitive Events are held as individual as well as group items. A panel of Judges drawn from reputed institutions judge the performances. The State Government is responsible for making arrangements of each venue with proper light and sound, uninterrupted power supply and all other logistic arrangements for smooth conduct of the competitive events. They are also responsible for making available sufficient number of volunteers at the venues of the competitive events. The conduct of the competitive events and non-competitive events is done by Nehru Yuva Kendra Sangthan (NYKS), an autonomous Organisation of this Ministry.

Competitive Events - Individual items

1. One Act Play (English or Hindi only)
2. Classical Vocal Solo
(i) Hindustani; and (ii) Carnatic
3. Classical Instrumental Solo
(i) Sitar (ii) Flute (iii) Tabla (iv) Veena; and (v) Mridangam
4. Harmonium (Light)
5. Guitar
6. Classical Dance
(i) Manipur (ii) Oddissi (iii) Bharatnatyam (iv) Kathak (v) Kuchipuddi
7. Elocution (Extempore)

Competitive Events - Group items

1. Folk Dance; and
2. Folk Song

Other events (Non Competitive):

- (i) A 'Young Artists camp' is organised by the NYKS where youth get a chance to show their creativity.
- (ii) Social development fair or 'Yuva Kirti' and food festival is organized by NYKS to provide an opportunity to young artisans to showcase their arts and crafts.
- (iii) A National Youth Convention on a chosen theme concerning the youth is another highlight in which around 700 youth participate. National Service Scheme (NSS) organizes this event.
- (iv) An 'Adventure Festival' is organised where various adventure activities are displayed by adventurers/ institutions.

- (v) A programme called 'Suvichar' is organised under which youth get an opportunity to interact with eminent personalities.

INFRASTRUCTURAL REQUIREMENTS

The infrastructural requirements for conduct of the festival are as under:

- (i) 4 to 5 big open spaces for Adventure and Exhibitions, at least 7 Auditoria of different capacity for various competitive Events)
- (ii) Provision for Accommodation and catering for the Youth Delegates
- (iii) Connectivity (Railway, Road and Airport)
- (iv) Provision of utilities (power, water supply, drainage)
- (v) Accessibility of local transport and Medical facilities
- (vi) Provision for Security

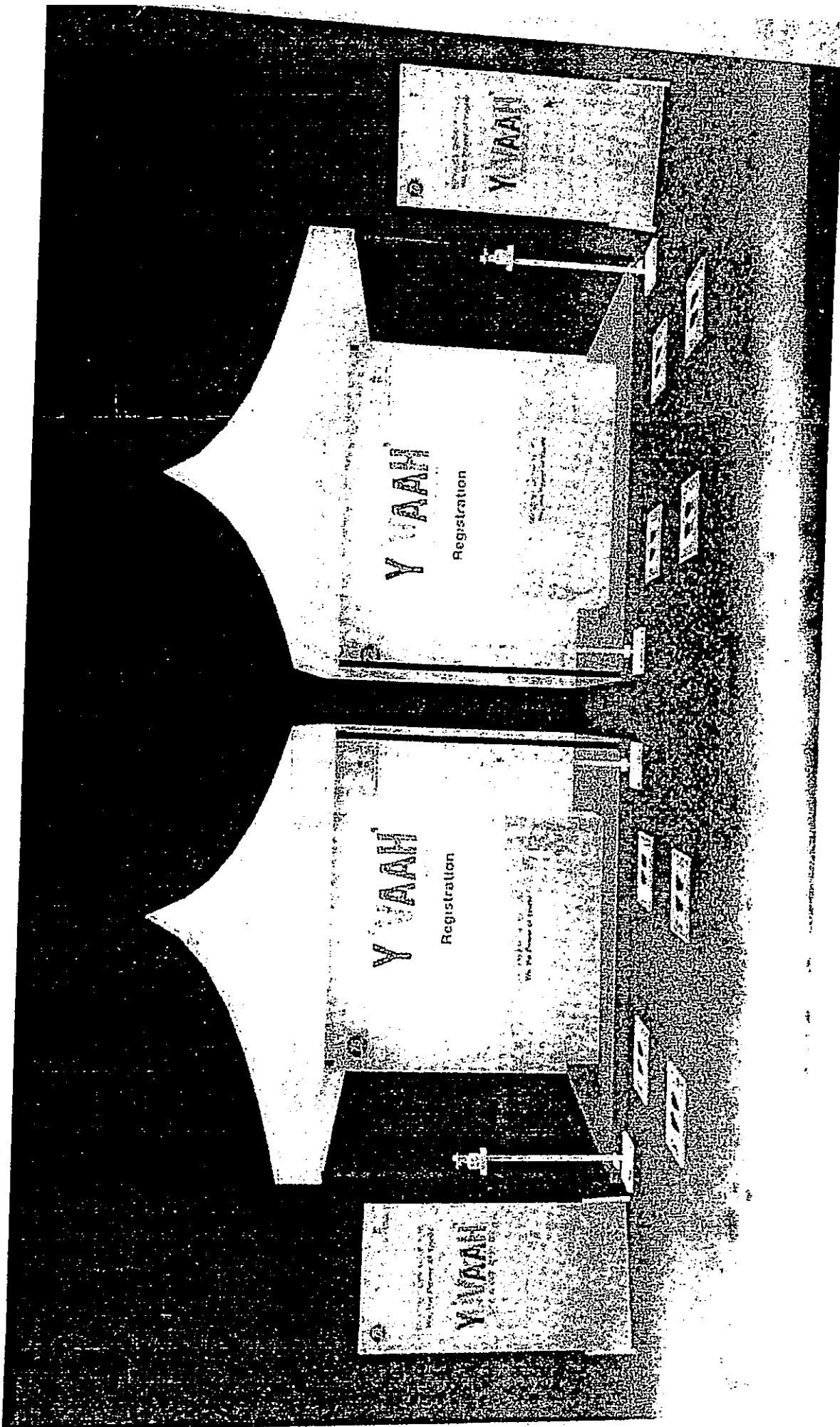
- i) State Government is responsible for providing necessary facilities and infrastructure for holding various events, making arrangements for boarding and lodging for all participants, officials, judges, invitees and guests, besides making arrangements for local transport.

As per terms of reference of the Work order being given to the Agency to be hired by this Ministry, the payment to the Agency will be made on pro-rata basis subject to actual expenditure incurred by the Agency.

The Agency will be required to deploy manpower in the States and also to carry out advertisement and Publicity of the Festival in the States/UTs.

Out of Central Govt.'s financial assistance of 15 Lakhs to be released to State/UT Govts., 90% advance will be released to the State/UTs within to conduct the Festival. The balance amount will be released upon receipt of Utilization Certificate. The State/UT Govts would be required to authenticate the bill submitted by Agency before the same may be considered by this Ministry for payment. The authenticated bills along with UC w.r.t to amount spent by the State/UTs may be submitted to this Ministry immediately after completion of the festival.

- ii) NYKS is responsible for organising 'Social Development Fair', Folk festival, Young Artists camp, Adventure Festival.
- iii) NSS organises the 'Youth Convention' and 'Suvichar'. However, logistic support is to be given by the State Government.
